Sweepstakes Rules

1. **Certification of Entrant:** By entering the **FC Cincinnati CollegeAdvantage College Savings Goal Giveaway** (the "Sweepstakes"), you agree to be bound by these Sweepstakes Rules and acknowledge that you have complied with these Sweepstakes Rules, including but not limited to verifying that you are an eligible individual as described in item five (5) below.
2. **No purchase required:** No purchase or contribution to a CollegeAdvantage Direct 529 Savings Plan is necessary to enter. No purchase or contribution will increase your chances of winning.
3. **Required information to enter:** You must provide your first and last name, date of birth including year, a valid email address, valid phone number, and your city and state of residence.
4. **Number of entries allowed:** One (1) entry per 24 hours, per email address.
5. **Eligibility:** To be eligible to enter and win, you must meet the following requirements from the time of entry through delivery of an Award (defined below), if applicable (each person meeting these requirements is herein referred to as an "Eligible Individual").
 - You must be at least eighteen (18) years of age and be of the legal age of majority in the jurisdiction in which you reside;
 - You must have a Social Security Number or Tax Identification Number;
 - You must be a legal resident who lives within (a) a seventy-five (75) mile radius of TQL Stadium ("Stadium") in Cincinnati, Ohio but excluding the Columbus Designated Area (as such term is defined below) and (b) the Designated Market Areas (as defined by Nielsen Media Research Company or any other entity selected by MLS in its reasonable discretion whose market definitions are commonly used in the media industry) of Lexington, Kentucky, Louisville, Kentucky, and Indianapolis, Indiana (the "Territory"). "Columbus Designated Area" shall mean the geographic area within the twenty-five (25) mile radius around the home stadium of the Columbus Crew (or any other MLS team that plays its home games in the Columbus, Ohio Designated Market Area).
 - You must **NOT** be an Employee or board member (or an immediate family member of such person) of Fussball Club Cincinnati, LLC, d/b/a Football Club Cincinnati ("Club"), Ohio Tuition Trust Authority ("OTTA" or "Sponsor"), the Ohio Department of Higher Education, Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM"), Pro Soccer Development, LP ("MLSNP"), and Player Development, LLC ("PDEV," and together with MLS, SUM, and MLSNP, the "MLS Entities") and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. Immediate family members are defined as: parents, children, spouses or siblings and their respective spouses, regardless of where they reside, and those living in the same households, whether or not related;
 - You must **NOT** have won a previous sweepstakes award(s) totaling two thousand five hundred (\$2,500.00) dollars or more from a sweepstakes sponsored by the Ohio Tuition Trust Authority in the previous thirteen (13) months from the date this award is drawn per item 9 below; and

7. **Enter by mail:** Eligible Individuals may, as an alternative, mail a 4"x 6" postcard with your first name, last name, date of birth including year, mailing address, valid telephone number, and a valid email address to: Ohio Tuition Trust Authority, FC Cincinnati CollegeAdvantage College Savings Goal Giveaway, 25 S. Front St., First Floor, Columbus, Ohio 43215-4176. Mailed entries must be postmarked by Friday, October 9, 2026, in order to be included in the drawing. Limit one entry, per postmark date, per stamped outer envelope.
8. **Deadline:** Deadline for entry online is 11:59 p.m. EST on Sunday, October 18, 2026.
9. **Drawing date:** A random drawing will be held by the Ohio Tuition Trust Authority ("OTTA") no later than Monday, October 19, 2026.
10. **Number of winners and Award:** One (1) Eligible Individual (the "First Place Winner") will be selected to receive a \$10,000 College Savings Award, which will be deposited into a CollegeAdvantage 529 Direct Plan College Savings account and a FCC Prize Pack, which shall consist of the following: one (1) scarf, one (1) customized jersey, four (4) \$20 FC Cincinnati team store gift cards; and four (4) hospitality suite tickets to the October 31, 2026, Promotion Game (collectively the "First Place Award"). Two (2) Eligible Individuals (the "Second Place Winners") will be selected to receive one (1) customized jersey (the "FCC Second Place Prize Pack").
11. **Winner notification method and date:** Winner of the Grand Prize Award will be contacted by email no later than Wednesday, October 21, 2026, and will have two (2) business days to claim their Award (the "Grand Prize Deadline"). After the Grand Prize Award has been accepted, the two Second Place Winners will be notified successively of their Awards by email. The Winners of those Awards will have two (2) business days from the time of notification to claim their Awards (the "Secondary Deadlines").
12. **Requirements for Grand Prize Award to be made:** Before the Grand Prize Award can be made, the Grand Prize Winner must:
 - Sign and return to OTTA, within two (2) business days of notification, an accurate, completed W-9 tax form and a Recipient Acknowledgement of Terms of Award and Release form, both forms to be provided by OTTA, and
 - Identify at least one (1) beneficiary, but not more than six (6) beneficiaries, into whose CollegeAdvantage 529 Direct Plan Account the Grand Prize Award will be deposited, and
 - Have, or establish within ten (10) business days of returning to OTTA a completed W-9 tax form and a Recipient Acknowledgement of Terms of Award and Release form, a CollegeAdvantage Direct 529 Savings Plan account(s), each with one designated Beneficiary and provide their eleven (11) digit account number(s) to OTTA via a completed Recipient Acknowledgement of Terms of Award and Release form. If establishing a new CollegeAdvantage Direct 529 Savings Plan account(s), no initial contribution from the Winner is necessary (the Award will constitute the initial contribution). If contributing to and/or establishing multiple CollegeAdvantage Direct 529 Savings Plan accounts (up to six (6) total with a minimum allocation of \$25 to each account), the Winner must designate how the Award is distributed across said accounts.
13. **Requirements for delivery of Two (2) Runner-Up Awards:** Before the Runner-Up Awards can be delivered, those Winners must sign and return to OTTA, within two (2) business days of notification, an accurate, completed W-9 tax form and a Recipient Acknowledgment of Terms of Award and Release form, both forms to be provided by OTTA.

Should Winner or any of Winner's guest(s) create an unreasonable disturbance or cause objects to be thrown or dropped from the Stadium, the Club shall have the right to eject the parties responsible for such action from the Stadium. Winner and Winner's guest(s) shall comply with all applicable present laws, ordinances, orders, rules and regulations applicable to the use of the Stadium and the activities conducted in the Stadium, including, without limitation, Club and MLS rule and regulations and shall not permit any violation thereof.

MLS game, event, and exhibition dates and times are determined in the sole discretion of MLS and/or the applicable MLS team, as applicable, and may be subject to change. Exact seat locations will be determined by Club, in its sole and absolute discretion. The terms and conditions of the tickets awarded as prizes will govern in the event a game, event or exhibition, as defined by MLS, is not played due to weather, an Act of God, pandemic (including the COVID-19 virus), an act of terrorism, civil disturbance, work stoppage or any other reason. As stated in item twelve (12) above, if the Grand Prize Award Winner chooses to establish one or more (up to six (6) total) new CollegeAdvantage Direct 529 Savings Plan account(s) for deposit of the Award, such account(s) must be established within ten (10) business days of this deadline, or the Award will be forfeited.
